# **RESIDENTIAL IRRIGATION SYSTEM SERVICE CONTRACT -** 2024-2025 **Details and Description of Program Service**

### **SPRINKLER SYSTEM - WINTERIZATION**: October 1 - December 31

- 1. Turn off controller
- 2. Shut off water supply to sprinkler system
- 3. Remove all water from sprinkler system using air compressor at 100 psi
- \* Please note: Broken or leaking heads or pipes may have to be repaired before system can be purged of water and will be billed accordingly.

#### **SPRINKLER SYSTEM - START UP**: March 15 - June 30

- 1. Program controller Check rain sensor, install new batteries, if necessary, at additional cost, unless supplied by customer.
- 2. Check solenoid valves for leaks and proper operation
- 3. Remove overgrown turf and dirt from around all sprinkler heads
- 4. Check all sprinkler heads for proper operation and adjust heads, if necessary
- 5. Check entire system for optimal coverage and performance
- 6. Notify customer in the event of leaks broken heads any potential problems are identified

# **SUMMER SPRINKLER INSPECTION AND ADJUSTMENT**: July 1 – August 15

- 1. Re-program controller to current weather conditions and check rain sensor
- 2. Check solenoid valves for leaks and proper operation
- 3. Check all sprinkler heads for proper operation adjust heads, if necessary
- 4. Check entire system for optimal coverage and performance
- 5. Notify customer in the event of leaks broken heads any other potential problems are identified

# FALL SPRINKLER INSPECTION AND ADJUSTMENT: August 15 - September 30

- 1. Re-program controller to current weather conditions and check rain sensor
- 2. Check solenoid valves for leaks and proper operation
- 3. Check all sprinkler heads for proper operation and adjust heads, if necessary
- 4. Check entire system for optimal coverage and performance
- 5. Notify customer in the event of leaks broken heads any other potential problems are identified
